- 4. Management Financial Report
  - Financial Report as of March 2025-Report included in the meeting packet. Report reviewed.
- 5. Committee Reports
  - A. Design Review Committee- Kevin Baker-Kevin reported that the painting is going well. Kevin noted there is an issue with some homes that have stuccoed walls that face common area. Outside patio walls being painted a brown color called cobblestone path. This has been a practice over the years but nothing in writing. HOA would have defined color for the outside and the property owner can paint the inside of their wall a different color unless it can be seen from the outside. Home faces east, texted painting contractor, planned to paint cobblestone path, homeowner wanted the wall to be the house color. This deviated from the precedent sent over the years.
  - B. Painting Committee-Silas Towler
    - 2025 Painting Almost Finished-Exterior painting discussed. Additional work quoted by the painter specific to the owner is the owners responsibility to approve. It was suggested that the painting policy should be updated regarding stuccoed walls. Kevin and Silas will work together on the language to be included. All painting work has been completed for 2025
  - C. Landscape Committee-Jerry Barden-meeting with landscaper on Thursday to review all irrigation issues. Will also review schedules. Jerry noted he would be gone from Mid May through July. David Lopez will look after crew while Jerry is away.
    - Recent Leaks Repaired-Looking at areas that need work next. Jerry noted that current landscapers users
      a bit higher end parts so will be more expensive. Southwest entrances need irrigation work. Several
      plants died over the winter and need to be replaced.

Ballpark estimate \$200. Laurie also asked handyman for cost to repaint inside of clubhouse. Currently awaiting invoice.
